## [Monthly comment]

In December, net sales totaled 108.9% for existing stores compared with the previous year and 119.4% for all stores.

In December, sales of winter apparel and home appliances such as heating equipment were favorable as there were many more low-temperature days compared with the previous year. In addition, as the weather was stable, sales of items of a variety of categories such as brand items, hobby-related items and sports and outdoor items performed strongly. Due to these factors, sales for both existing stores and all stores increased year on year.
