Notice Regarding Transition to a Company with an Audit & Supervisory Committee, and Appointments of Directors and Executive Officers

Daio Paper Corporation ("Daio") hereby announces that the Board of Directors resolves at its meeting held on February 14, 2025 that (i) transition from a "Company with an Audit & Supervisory Board" to a "Company with an Audit & Supervisory Committee" subject to approval at the 114th Annual General Meeting of Shareholders ("114th AGMS") scheduled to be held on June 26, 2025; (ii) the Board of Directors members candidates who will be submitted to the 114th AGMS; and (iii) introduction of a delegated executive officer system to further strengthen business execution, and appointments of executive officers as of June 26, 2025.

1. Transition to a Company with an Audit & Supervisory Committee

(1) Purpose of the Transition

Based on its corporate philosophy of "Shaping an Abundant and Affable Future for the World," the Daio Group aims to realize sustainable value creation for all stakeholders and society as a whole by promoting sustainability management.

To date, the Board of Directors has been responsible for making important management decisions and supervising business execution. Meanwhile, as a Company with an Audit & Supervisory Board, an Audit & Supervisory Board and its members, independent from directors, have conducted audits on the status of business execution and other matters.

Amid the rapidly changing business environment surrounding the Daio Group, the transition to a Company with an Audit & Supervisory Committee will allow the Board of Directors to focus on discussing and deciding on matters such as medium- to long-term management strategies. It will also help to increase our corporate value by further enhancing corporate governance through strengthened monitoring functions, as well as further accelerating decision-making by delegating authority.

In conjunction with the transition to a Company with an Audit & Supervisory Committee, Daio will increase the number of independent outside directors as members of the Nomination Committee and the Remuneration Committee respectively, thereby enhancing the transparency and objectivity of decisions on the nomination and remuneration of directors.

(2) Schedule for Transition to a Company with an Audit & Supervisory Committee

At the 114th AGMS, Daio plans to obtain approval to proposals to amend the Articles of Incorporation, etc. for the transition to a Company with an Audit & Supervisory Committee as of June 26, 2025.

The details of amendments to the Articles of Incorporation relating to the transition to a Company with an Audit & Supervisory Committee will be announced as soon as they are determined.
