## Notice Concerning Unauthorized Access of a Group Company's System

DTS CORPORATION hereby announces that it has recently discovered that unauthorized access by a third party has occurred in the system of one of its group companies, DIGITAL TECHNOLOGIES CORPORATION ("DIGITAL TECHNOLOGIES"), and that there is a possibility that some information held by DIGITAL TECHNOLOGIES has been leaked.

We have established an internal task force to deal with this incident, and a team of experts, including outside digital security specialists, is currently investigating the cause of the incident and the extent of the impact, and is working to restore the system. We sincerely apologize for any inconvenience and concern this may cause to our customers and other stakeholders.

Although it will take some time for us to gain a full picture of the incident, we would like to report what we know at this time as follows.

## 1. Course of the incident

On February 17, 2025, Japan time, DIGITAL TECHNOLOGIES experienced a system failure that resulted in a partial service outage. We asked an external company specializing in digital security to investigate the cause of the outage, and it was confirmed that DIGITAL TECHNOLOGIES' systems had experienced unauthorized access. We immediately initiated a detailed investigation with the assistance of outside experts and set up a company-wide task force to quickly address the situation.

## 2. Current situation and future actions

As part of our actions, we have taken steps to disconnect the affected servers, etc. from the Internet and internal networks. As a result, some of DIGITAL TECHNOLOGIES' internal systems have been rendered unavailable.

We are currently investigating the full extent of the incident, including the scope and cause of any impacts. At the same time, we are working to restore DIGITAL TECHNOLOGIES' internal systems and resume normal operations as soon as possible.

## 3. Information leakage

DIGITAL TECHNOLOGIES is currently conducting an investigation to identify information that may have been leaked (e.g., personal information and other confidential information) with the assistance of experts, including an external digital security company. We have also made reports to the relevant authorities as necessary. We will promptly disclose any matters that may arise in the course of our

investigation.

In addition, DIGITAL TECHNOLOGIES has consulted with the police regarding this incident, and has also reported it to the Personal Information Protection Commission.

Again, we sincerely apologize to our business partners and other stakeholders for the great concern and inconvenience we have caused.

At this time, there has been no unauthorized access to our company or any other group companies. We are currently examining the impact of this incident on our Group's financial results forecast for the current fiscal year, and if we determine that a revision to the forecast is necessary, we will promptly disclose the details.
