Notice of Transition to a Company with Audit & Supervisory Committee and Changes in Officers

Universal Entertainment Corporation (hereinafter referred to as "UEC") hereby announces that at the Board Meeting held today, UEC resolved the transition from a company with Audit & Supervisory Board to a company with Audit & Supervisory Committee subject to the approval of the resolution at the extraordinary general shareholders' meeting to be held on July 23, 2025 (hereinafter referred to as "the Extraordinary Shareholders' Meeting"). For the transition, matters regarding the candidates for directors to be proposed at the Extraordinary Shareholders' Meeting were also resolved at the Board Meeting held today. Details are as follows.

Regarding to the partial changes to the Articles of Incorporation due to the transition to a company with Audit & Supervisory Committee, please refer to "Notice of Partial Changes to the Articles of Incorporation in Line with the Transition to Company with Audit & Supervisory Committee" which was released today.

1. Transition to Company with Audit & Supervisory Committee

(1) Aim of the Transition

UEC intends to transition to a company with Audit & Supervisory Committee with the aim of strengthening the corporate governance by the enhancement of the supervisory function of the Board and hence inteisifying the framework for the oversight function of management by changing the status of members of the Audit & Supervisory Board, which oversees the performance of the directors, to members of the Board who have the right to cast a vote at the Board Meeting.

(2) Schedule of the Transition

The transition to company with Audit & Supervisory Committee is to be completed at the conclusion of the Extraordinary Shareholders' Meeting provided that the necessary changes to the Articles of Incorporation are to be resolved in the Extraordinary Shareholders' Meeting.
