1. Overview of business partnership

As was announced today in the "Notice Concerning Change in Consolidated Subsidiary (Share Transfer)," the Company and Sun Asterisk, have engaged in dialogue following the transfer of the consolidated subsidiary GlobalGear Co. Ltd., and have found the possibility of creating synergies in each other's growth strategies. The conclusion of this business partnership agreement is positioned as the first step for the two companies to deepen mutual understanding from a long-term perspective and explore various collaboration opportunities.

The Company Group is currently streamlining its personnel structure and fundamentally reviewing its business structure. Going forward, by receiving the technology, know-how, experience, human resources and other resources that Sun Asterisk has cultivated in its digital creative studio business, the Company will aim to further streamline its management and achieve further business growth and maximization of its corporate value.
