Daiseki has been recognized for its leadership in corporate transparency and performance on climate change by the global environmental non-profit CDP, securing a place on its annual "A List" for the third consecutive year. In 2025, 640 institutional investors, representing over US\$127 trillion in assets, requested environmental impact, risk, and opportunity data through CDP, and more than 22,100 companies disclosed their environmental data through the platform.

A detailed and independent methodology is used by CDP to assess these companies, allocating a score of A to D- based on the comprehensiveness of disclosure, awareness and management of environmental risks and demonstration of best practices associated with environmental leadership, such as setting ambitious and meaningful targets. Those that do not disclose or provide insufficient information are scored an F.
