Image of the Satellite Constellation Project

This project is a Private Finance Initiative (PFI) aimed at establishing a satellite constellation<sup>1</sup> operated by private companies to ensure the stable acquisition of imagery essential for maintaining the effectiveness of stand-off defense capabilities<sup>2</sup>. Existing commercial satellite imagery services may not consistently deliver images when required by MOD. Through this project, SKY Perfect JSAT and its partners will work to ensure stable and timely image acquisition by building and operating a dedicated satellite constellation, which will provide MOD priority imaging rights. SKY Perfect JSAT, in partnership with Mitsubishi Electric and Mitsui, plans to conclude a basic agreement with MOD regarding this project in January 2026. Following that, the three companies will establish a special-purpose company as required of the successful contractor, and in February, this entity is scheduled to execute a project contract with MOD.

Looking ahead, SKY Perfect JSAT will continue to fully leverage the experience, technologies, and assets cultivated over four decades in the space business since its founding in 1985, contributing to strengthening Japan's national security and reinforcing its defense industrial foundation.

- 1 Satellite constellation: A system of multiple small satellites operating together in low Earth orbit (about 200-2,000 km altitude).
- 2 Stand-off defense capability: the ability to counter targets from outside the threat zone
